WE ARE WORKING TO GO CARBON NEUTRAL BY THE YEAR 2040

ENERGY EFFICIENCY

20% REDUCTION OF CARBON EMISSIONS

We have enrolled in 4,766kW of solar energy production. Each year, one third of all of our power consumption for CITY's facilities is now provided from zero carbon solar energy. This has reduced our carbon emissions by over 20%.

TOP FLEET IN AMERICA FOR 8+ YEARS

We were the first in our industry to convert 100% of delivery trucks to CNG. Approximately 60% of the CNG we use is Renewable Natural Gas.

RECYCLING

8,500,000

With the addition of Plant City in 2022, we now operate four state-of-the-art recycling centers. We're able to recycle almost everything that comes through our doors, keeping 8,500,000 pounds of waste out of landfills each year.
